OBJECTIVE:

The purpose of this memorandum is to announce implementation of the City's First-Time Home Buyer Programs.

BACKGROUND/DISCUSSION:

The Neighborhood Improvement Division of the Community and Economic Development Department will be administering two First-Time Homebuyer Programs.

Workforce Initiative Subsidy for Homeownership Grant (WISH Program)

In partnership with Pacific Mercantile Bank and Benchmark Mortgage, the City will be promoting the WISH Program, which is administered by the Federal Home Loan Bank in San Francisco. Pacific Mercantile Bank has set-aside \$45,000 dollars of WISH Grant funds for the City of Garden Grove to be utilized for a first-time home buyer program. The WISH Program provides for the following:

- Down payment assistance to low-income residents who are looking to purchase their first home in Garden Grove.
- The WISH Grant is forgivable after five years.
- The WISH Grant is designed to match the resident's down payment three to one. For every dollar a local resident uses as a down payment, the WISH Grant will match with three dollars, up to a maximum amount of \$15,000 dollars.

CalHOME First-Time Home Buyer Program

The creation of the City's First-Time Home Buyer Program repurposes over \$650,000 dollars of CalHOME funds that are available through the City's CalHOME Reuse Account. The CalHOME loans provides for the following:

Eligible low-income residents may apply for a low-interest second mortgage loan of up to \$60,000.

- The CalHOME loan is structured as a 30-year deferred loan with no monthly payments and is designed to cover the difference between a qualifying mortgage amount and the actual price of a single-family home.
- The CalHOME loan provides a resource for individuals seeking to purchase a home in Garden Grove but unable to secure the full amount of financing through a traditional mortgage.

First-Time Home Buyer Workshops hosted by Neighborhood Improvement The City is providing First-Time Home Buyer Workshops to educate prospective home buyers on the home purchasing process and will provide information regarding the City's program. Two workshops are to be held scheduled on Saturday, January 5, 2019 and Saturday, February 2, 2019 from 9:00 a.m. to 12:00 p.m. at the Garden Grove Courtyard Center located at 12732 Main Street, Garden Grove, CA 92840.

The week of December 10th, marketing and outreach of the First-Time Home Buyer Programs will take place through press releases, social media posts, the City website, the City's First Time Home Buyer Workshops, and program flyers. City staff has been collaborating with the County of Orange, and the Cities of Westminster and Santa Ana regarding a proposed Class IV bikeway on Hazard The County of Orange received a grant from the California Transportation Commission to install a Class IV bikeway on Hazard Avenue, from Euclid Street in Garden Grove to Goldenwest Street in Westminster. Garden Grove's portion of the bikeway is on an approximately 1 mile segment of Hazard Avenue from Euclid Street to Brookhurst Street. Santa Ana received a separate grant to install a Class IV bikeway on Hazard Avenue within its city limits.

A Class IV bikeway is designed to be separated from motor traffic to provide a safer bicycling environment. Exhibit "A" attached shows existing lane configuration on Hazard Avenue and proposed lane configuration with the addition of the Class IV bikeway. Hazard Avenue currently has two travel lanes in each direction with parking on both sides. The proposed lane configuration consists of one center turn lane, one travel lane in each direction, one parking lane in each direction and one Class IV bike lane in each direction.

In October 2017, Orange County staff hosted an interactive "Go Human" bicycle event at James Irvine Intermediate School in Garden Grove to raise awareness for the project. The County's consultant also made a brief presentation at the City Council meeting to introduce the project. As part of the project's continued outreach program, County staff plans to conduct community meetings to receive input from the public. The first session is tentatively scheduled for December 12, 2018 at 6 p.m. at James Irvine Intermediate School. Meeting notices will be mailed to all residents and businesses within .25 mile of the project limits. A copy of the County's project fact sheet is attached for additional information. Orange County staff also plans to make a presentation at the City Council Meeting in Fabruary 2019.






WHEN

With public input, the County of Orange is looking to refine the initial design concept and use grant funding to construct the project in 2020*. Your input is requested to better determine the final design. *Santa Ana's portion from Euclid to Harbor is scheduled for 2019.



Grant funding has been secured to improve 5-miles of Hazard Avenue between Goldenwest Street and Harbor Boulevard through the cities of Westminster, Garden Grove, and Santa Ana. There is also a potential future bikeway link that will connect easterly from Harbor to the Santa Ana River, southerly on N. Jackson Street and easterly on Fifth Street.



Leaders celebrate start of OC Streetcar construction

The shiny ceremonial shovels and pile of pre-mounded dirt were merely symbolic, but the milestones Orange County transit and local officials celebrated Friday were real.

Santa Ana and Garden Grove city leaders, Orange County Transportation Authority executives and the acting administrator of the Federal Transit Administration gathered to mark the groundbreaking for the county's first modern streetcar and announce \$149 million in federal funding, a crucial piece of the \$408 million project.

Getting the project to this point took 10 years of perseverance, Orange County Supervisor Andrew Do said during a ceremony at the Santa Ana Regional Transportation Center, which will be one endpoint for the 4.1-mile streetcar line.

Santa Ana Mayor Miguel Pulido jokingly compared the process to giving birth after a very long gestation, and in an earlier phone interview he noted that a lot of things had to go right to get to the start of construction, including funding, political and community support and the environmental review.


"It's a very long process and anything can derail you," Pulido said.

Also on Friday, officials celebrated the signing of an agreement that brings federal funding for the streetcar to \$217 million, more than half the project total. State and local dollars will make up the rest. It's rare in Orange County for a transportation project to get the bulk of its money from outside the region, OCTA spokesman Eric Carpenter said.

"That's one thing that we've always promised with Measure M is to try to leverage local dollars," Carpenter said, referring to a voterapproved county transportation sales tax. "We think this does exactly that."

The estimated \$5 million annual cost to operate the system will be funded with local revenues includ-

expected to cost the same as OCTA buses, and money from Measure M, Santa Ana and Garden Grove, OCTA spokesman Joel Zlotnik said.

Utility work for the project is underway and officials are working out the logistics of the construction schedule. When operational, which is expected by late 2021, six electric streetcars will visit 10 stops along the 4.1-mile streetcar line every 10 to 15 minutes. OCTA projects about 7,300 riders per day within the first year, in part because the streetcar will replace some existing bus routes.

The electric streetcars, powered by overhead wires, will run on tracks partly in shared lanes with other vehicles, and partly along an old Pacific Electric "red car" right-of-way.

Santa Ana boasts the county's largest volume of ing rider fares, which are bus riders, Pulido said, so

The route will run from the Santa Ana train station to Garden Grove's transit station, with part of it using Fourth Street and Santa Ana Boulevard.

The lengthy construction was initially a concern for some businesses, said Raul Yanez, a business owner and president of the Santa Ana Business Association.

As long as OCTA sticks to its plan of building the project in phases rather than tearing up a whole street at once, Yanez said, "I think it's a good thing that it's coming.

Joe Castro, owner of the Barrel Room wine bar and bistro on Fourth at North Birch Street, said the streetcar could offset the annoyance of parking and paying the downtown meters.







Among those opposed was Ariana Escalera, a GGUSD parent who said "There is nothing this charter offers that is better than what we have now."

Another, Sandy Lopez, called the charter plan "insulting," referring to comments made at a public hearing on the proposal on Oct. 16.





The Orange County Transportation Authority on Friday brought together local, state and federal officials to accept a \$149 million federal funding grant and to mark the start of construction on the county's first modern electric streetcar.

Federal Transit Administration Acting Administrator K. Jane Williams and OCTA CEO Darrell E. Johnson signed a Full-Funding Grant Agreement at the Santa Ana Regional Transportation Center, which with other federal funding will pay

for more than half of the approximately \$408 million OC Streetcar project.

(https://orangecountytribune.files.wordpress.com/2016/08/octa-logo.jpg)Following the signing, transportation officials joined with leaders from Santa Ana and Garden Grove – the two cities that originally developed the project – and with business and community leaders to break ground on the OC Streetcar.

"This is a truly exciting day as we officially begin construction on a new travel option in Orange County's urban core where public transit is critical in moving residents, employees and visitors on a daily basis," said OCTA Chairwoman Lisa Bartlett, also the county's Fifth District Supervisor.



The acceptance of the FTA's \$149 million grant follows years of close coordination between OCTA and the FTA to plan the rail transit line. The route goes from the Santa Ana Transit Center and connects the downtown of the county seat to Harbor Boulevard in Garden Grove, using city streets and the old Pacific Electric right-of-way.

Construction is expected to start in 2019, with testing and operation in 2021.

League's 2018 Legislative Briefing Book Now Available Online

December 3, 2018

The League of California Cities® posted on its website a comprehensive summary of the 2018 Legislative and Ballot year, along with descriptions, divided by issue area, of the hundreds of bills of interest to cities that passed the Legislature and were signed into law by Gov. Jerry Brown.

League lobbyists prepare this document at the conclusion of each legislative year as a resource to assist city officials understand laws enacted during the 2018 session.

This report was originally provided to city officials via a webinar hosted by the League's lobbying team on Nov. 13. The report is now available for download on the League's <u>website</u>.

League Board Establishes 2019 Strategic Goals

Improving Disaster Preparedness, Recovery, and Climate Resiliency; Addressing Affordable Housing and Homelessness Challenges; Promoting Sustainability of Public Pensions and Addressing Public Safety Concerns are all Priorities for League in New Year

December 3, 2018

The League Board of Directors, joined by leadership from the League's divisions, departments, policy committees and diversity caucuses convened in Garden Grove last week for the annual League Leaders Workshop in a retreat setting to develop the organization's strategic goals for 2019.

This annual event provides an opportunity for city leaders to reflect on the prior year's work, discuss current challenges, and establish League priorities as the organization continues to serve as the leading voice of California cities.

During the two-day format, attendees received presentations on progress on the League's 2018 priorities, results of recent state ballot measures, insight on voter trends, priorities of Governor-elect Gavin Newsom and legislative leadership.

Disaster Preparedness, Increased Housing and Homelessness Resources, Public Pension Stability and Public Safety take Center Stage

League President Jan Arbuckle, council member, Grass Valley, led the approximately 100 League leaders in attendance through the goal-setting process, where many pressing issues affecting all California cities were discussed.

In response to the recent wildfires that have devastated communities throughout the state, the city officials discussed the importance of expanding resources and partnerships for not just disaster recovery, but to improve community preparedness and resiliency to respond to climate-related, natural and man-made disasters

League leaders also discussed the challenges facing the state on housing, including the lack of affordable housing funding since the loss of redevelopment. Also mentioned was the recent report by the state Legislative Analyst predicting a slowdown in production due to market forces which include increasing supply, higher interest rates, and decreasing prices which cause private builders to slow production. As the Legislature grapples with this problem it will remain critical to ensure that funding and tools are made available to build affordable units and address the homelessness crisis in California. Moreover, the

Legislature can lead on the issue by providing CEQA streamlining to expedite housing construction, dedicating a portion of the state's budget surplus to construct affordable housing and expand skilled workforce training.

Participants agreed to continue to collaborate with partners to raise awareness of the state's significant unfunded pension liability and the growing fiscal challenge this poses for California cities, and to also address public safety concerns of California cities and support additional resources needed to address critical community challenges.

Strategic Goals Adopted for 2019

The League Board of Directors approved four strategic goals for 2019:

1. Provide Cities Additional Funding and Tools and Preserve Local Authority to Address Housing Production, Affordability and Homelessness Challenges.

- Provide additional funding and preserve local mitigation fee authority to ensure cities have sufficient resources to update local plans that reflect community input, improve and expand local infrastructure, address environmental impacts and deliver services to support new housing development.
- Restore a robust form of tax increment financing to advance transit-oriented development, build affordable and workforce housing, improve jobs/housing balances, and revitalize local neighborhoods and communities.
- Increase resources to provide emergency shelter, alcohol and drug treatment, housing, mental health and other wrap-around services and facilities to assist people of all ages, including seniors, experiencing homelessness.
- Provide CEQA streamlining to expedite housing construction.
- Ensure the availability of adequate water supplies to support new growth.
- Preserve local authority to ensure housing development is consistent with local housing elements, design requirements and other applicable criteria adopted with community input.
- Given California's massive identified deficit in affordable housing, the Legislature and Governor should set aside a substantial amount of the state's budget surplus to support additional affordable and workforce housing construction and expand skilled workforce training.

2. Improve Disaster Preparedness, Recovery and Climate Resiliency.

- Provide resources to cities and expand partnerships to better prepare for and recover from wildfires, seismic events, erosion, mudslides and other disasters.
- Improve community preparedness and resiliency to respond to climate-related, natural and man-made disasters.

3. Promote Sustainability of Public Pension and Retirement Health Benefits.

- Continue to work with employee organizations, CalPERS, the Administration and the Legislature to drive public awareness of the fiscal challenges cities face as a direct result of growing unfunded pension liabilities and retirement health benefits.
- Work collaboratively to achieve meaningful options and flexibility for cities to address these
 challenges in order to stabilize local budgets and ensure sufficient funding remains available to
 provide services to communities.

4. Address Public Safety Concerns of California Cities.

- Reform recently enacted criminal justice laws enacted by both statute and initiative that
 have eroded public safety protections of California residents through the passage of the Police
 Chiefs/Grocer's-sponsored criminal justice reform measure eligible for the November 2020
 state ballot, or by equivalent reforms achieved through legislative action.
- Protect public safety by reducing access to firearms for the mentally ill.
- Protect existing city authority to deliver local emergency services.
- Support additional tools and resources to address critical community challenges such as homelessness, mental health, domestic violence, drug rehabilitation, human trafficking and workforce development for ex-offender reentry.

California Supreme Court Hears Oral Argument in Highly Anticipated Pension Reform Case

December 6, 2018

The California Supreme Court heard oral argument on Wednesday, Dec. 5 in *Cal Fire Local 2881 v. California Public Employees' Retirement System* — a case that may have important implications for cities struggling to address rising pension costs.

As the League previously <u>reported</u>, the case involves a challenge to a provision of the California Public Employees' Pension Reform Act ("PEPRA") that eliminated the option for employees enrolled in CalPERS to purchase up to five years of service credit (commonly referred to as "airtime") to add to their pension benefit. In deciding the case, the California Supreme Court has an opportunity to reconsider longstanding precedent known as the "California rule," which often prevents employers from modifying pension benefits for employees enrolled in CalPERS or another public pension system. However, the Court could decide the case on narrower grounds.

The California rule applies only to pension benefits that are "vested," meaning that they are constitutionally-protected contract rights. If the Supreme Court rules that the option to purchase airtime was not a vested contractual right, then the lawsuit fails.

At oral argument, the union's attorney argued that all aspects of a pension benefit as it exists on the first day of an employee's employment become vested because each aspect is a part of the promise made to induce the employee to accept the position and therefore constitutes a form of deferred compensation. The state's attorney countered this argument by citing California Supreme Court precedent holding that there is a presumption against finding that statutes — as opposed to contracts — create vested contractual rights. The state's attorney pointed out that there was no language in the statute to indicate that the Legislature intended for the benefit to vest such that it could not be eliminated or modified in the future.

The questions from the Bench seemed to indicate that the Court will agree with the state's argument on this point when it issues its ruling next year. If the Court does agree with the state that the right was not vested, it is not necessary for the Court to address the California rule, since the rule does not apply to benefits that are not vested.

The Court has four other cases pending on its docket that implicate the California rule. Three of those cases are being held in abeyance pending the outcome of this case. The one remaining case — *Alameda County Deputy Sheriff's Association v. Alameda County Employees' Retirement Association* — is fully briefed and can be set for oral argument anytime.

Under the California Rules of Court, once oral argument is held and the Court takes the case under submission, it has 90 days within which to issue an opinion. The League will continue monitoring both cases and will provide further updates as they are available.
