Re: Urgent Request to Reopen Nail Salons in Stage 3 Initial Phase

Dear Governor Newsom:

The City of Garden Grove commends you for your work in facilitating and expediting the reopening of the State's economy guided by medical and public health criteria. **As California moves into the initial round of Stage 3 openings, we urge you to allow nail salons to reopen immediately.** Nail salons represent a very prominent industry in Garden Grove that has been especially impacted by the COVID-19 pandemic.


The State is continuing to release guidance for reopening more and more businesses; however, nail salons are notably absent. This is unfair and deeply concerning to our many nail salon workers and entrepreneurs—most of whom are Vietnamese-Americans. This group of workers was already vulnerable and is now struggling to survive economically. Many manicurists worked seven days a week to make ends meet prior to the pandemic and now have been plunged into precarious financial straits. We've heard from manicurists who cannot make rent or pay for their child's medical care. Moreover, we know that many families work entirely for the nail salon business and that entire working families are being devastated financially.

Just as hair salons and barbershops have been provided with industry guidance and authority to reopen, nail salons should be provided the same opportunity now rather than later. Both industries are very similar and both industries have the ability to implement practices and protocols to ensure customer safety. In fact, the all-volunteer team of Nailing It for America, based in Garden Grove, and many other stakeholders across California have been working to facilitate the development of nail salon industry guidance that would ensure safe reopening.

The City of Garden Grove appreciates your consideration of this urgent request and looks forward to your partnership and support as we work to protect Californians and reopen our economy.

OBJECTIVE

Provide information about the reopening strategy for SteelCraft Garden Grove.

BACKGROUND/DISCUSSION

Discussions with SteelCraft continues about the status of reopening. To date, two operating reports have been provided detailing information about implementing the State's guidelines as well as the status of the tenants operations. Provided is a brief synopsis of each operating report.

Operating Report No. 1:

Approximately two tenants reopened for pick-up and to-go orders only. Two additional tenants are making plans to open soon.

Operating Report No. 2:

Approximately six tenants have since reopened along with the option to dine-in. One tenant, Honey & Butter, will not be returning to SteelCraft.

CONCLUSION

Staff will continue to extend business development support to SteelCraft and future tenants.

SteelCraft Garden Grove Operating Report #1

Implementation of California Guidelines for reopening restaurants and/or expanding beyond:

Written Plan, Training and Communication, Face Masks, Gloves, Social Distancing, Regular Sanitizing and Disinfecting, Hand Washing, Contactless Payment options, Order Online for Pick up, Removal of all shared food items and utensils and dispensers, Disposable Menus, Removed all shared entertainment, Gates/Doors are propped open, Removal of 50% of bar stools to help maintain social distancing guidelines. Restrooms are currently for employees only. Rules are posted at each entrance for guests to see.

Policy on social distancing:

Yes, we are implementing the 6ft markers on the ground to help people identify where to stand while in line and we will maintain this policy moving forward. Once we are permitted to open for dine-in customers, we will have tables strategically blocked off to ensure social distancing measures are adhered to. We have removed half of our barstools and spaced out the remainder of the stools six feet apart.

Opening date for pick-up:

Currently SteelCraft Garden Grove is open for pick-up and to-go orders only. Two tenants have been open for to-go orders with two more making plans to open soon.

Opening date for sit-down:

As an outdoor eatery with natural social distancing, we believe we have a responsibility to the community as a safe option for dining during the reopening of our nation. We are prepared to open as soon as the governor, county and City officials allow us to.

Days and hours of operation:

Each of our tenant-partners have differing hours and days of operation, currently the two tenants that are open are open 7 days a week between the hours of 12pm-8pm. When we reopen for sit down dining, we anticipate opening for limited hours at the outset and gradually expanding the hours back to normal operating hours as customer demand begins to return.

SteelCraft Garden Grove Operating Report #2 Update

1. Implementation of California Guidelines for reopening restaurants and/or expanding beyond:

Although Gov. Gavin Newsom approved Orange County's request for reopening of Phase 2 businesses including in-restaurant dining and shopping centers on Saturday, May 23rd, 2020, SteelCraft Garden Grove chose to wait to publicly announce that we are open for dine-in until Friday, May 29th, 2020. During that time the following protocols and measures have been implemented:

- **Cleanliness and sanitation:** Our facilities have undergone thorough deep cleanings and sanitations continue daily. Cleaning assignments and schedules have been created for all staff and areas of operation. All high touch surfaces are disinfected regularly, and tables and chairs are sanitized between every seating. All products used are rated for restaurants and effectively disinfect for COVID-19. Frequent hand washing and use of hand sanitizer is required for all staff. We also have hand sanitizer stations placed at each entrance for guests.
- **Physical distancing:** Our dining areas have been rearranged to allow for 6-foot distancing between tables along with sufficient spacing in passages for traffic between guests and staff.
- **Face mask policy:** Face coverings/masks are required on-site for all SteelCraft and vendor employees and are strongly encouraged for customers when not eating or drinking.
- **Staff:** All onsite SteelCraft and vendor employees undergo daily wellness and temperature checks upon arrival. Any staff member displaying signs of illness will be immediately sent home.
- **Games:** For the time being to maximize sanitation efforts, we will not be putting out the yard games or opening the arcade.

2. Policy on social distancing:

SteelCraft Garden Grove worked with the City of Garden Grove to obtain Garden Grove branded social distancing floor decals which SCGG has implemented to help guests identify where to stand while waiting in line. In addition, 50% of barstools have been removed and tables have been strategically blocked off with red tape to adhere to the 6' social distancing requirement.

3. Opening date for pick-up:

One of SteelCraft Garden Grove's tenants opened for pick-up, delivery and curbside services starting on May 6th with a few tenants beginning to do so soon after. The open tenants at SCGG are still offering take-out and/or delivery.

4. Opening date for sit-down:

As an outdoor eatery with natural social distancing, we believe we have a responsibility to the community as a safe option for dining during the reopening of our nation. We were prepared to open on Friday, May 29th, 2020 soon after the governor, county and City officials announced that in-restaurant dining and shopping centers were able to do so. Due to strict state guidelines, every alcohol purchase intended to be consumed onsite must include proof of purchase of a meal from one of the SteelCraft Garden Grove food tenants.

5. Days and hours of operation:

Each of our tenant-partners have differing hours and days of operation. Currently, the days and hours of operation are as follows in the chart below:

12. Additional information

SteelCraft Garden Grove, its employees, its tenants and their employees have been facing one challenge after another. The first came when the county abruptly announced restaurants could reopen dining rooms over the holiday weekend. The next came as the concern for protests with acts of looting and vandalism affecting the surrounding cities. And now, in response, the local government has declared curfews forcing the businesses to close and local guests to be home before the mandated curfew time.

In light of recent events including protests in the surrounding area as well as the mandated citywide curfew effective from 6:00pm on Tuesday, June 2nd, 2020 to 5:00am Wednesday, June 3rd, 2020 and from 6:00pm Wednesday, June 3rd, 2020 to 5:00am Thursday, June 4th, 2020, SteelCraft Garden Grove and its tenants have chosen to close early on Tuesday, June 2nd and remain closed all day on Wednesday, June 3rd to ensure the safety of employees and guests. The sudden and confusing rollout of COVID-19 rules, requirements and criteria as well as the concern around safety and protection of the development's employees and property has caused the small businesses at SteelCraft Garden Grove continue to struggle to gain customer traction.

OBJECTIVE

Communicate an update of the Urban and Community Forestry Grant Program.

BACKGROUND

On May 30, 2018, the City was awarded a Cal Fire grant in the amount of \$573,931 along with a City-matching amount of \$216,244 for a total project cost of \$790,175 to undertake a City-wide planning and tree-planting project comprised of three key tasks:

- Task 1:** Develop an Urban Forest Management Plan (Plan) and update the City's Tree Ordinance;
- Task 2:** Plant 363 trees on the PE ROW Trail from Nelson Avenue to Brookhurst Street; and
- Task 3:** Engage Community Participation as well as develop a City Tree Webpage and Tree Brochure.

DISCUSSION

On June 11, 2019, the Davey Resource Group (DRG) was retained to draft the Urban Forest Management Plan and Tree Ordinance. On November 27, 2019, David Evans and Associates, Inc. (DEA), was engaged to draft the landscape plans.

Task 1:

To date, DRG has completed drafts of the GIS Urban Tree Canopy Mapping; Urban Tree Canopy Assessment; Resource Analysis; document layout; updates to the City's Tree Ordinance; Stakeholders questionnaire; and held Stakeholders meetings and one-on-one interviews; and, implemented an online Tree Survey.

Task 2:

DEA, in coordination with the Public Works Engineering and Real Property Division, completed the landscape plans, and the plan check review has been initiated. Additionally, preparation of the request for proposal for the installation of the landscape and irrigation system is in progress.

URBAN AND COMMUNITY FORESTRY GRANT PROGRAM UPDATE

June 11, 2020

Task 3:

On February 18, 2020, DRG held a Community Outreach Meeting in which 15 residents attended. Due to the recent COVID-19 pandemic, the scheduled outreach events were canceled and future pop-up events are planned to gather additional community input. A component of the Community Participation involved an online City-wide K through 12th grades Tree Contest with selected artwork to be included in the final Plan. The voting is taking place now and through June 26th, via the City's Facebook page. A sampling of submitted artwork by Garden Grove students is attached. Development of the webpage for the Urban Forest Management Plan can be found on the Planning Services page (<https://ggcity.org/planning/urban-forest-management-plan>). The tree brochure is in the first review phase.

CONCLUSION

The next step, is the selection of a construction management company to assist with overseeing the installation of the landscape and irrigation system. Upon approved plans, the City will issue the request for proposal for the installation of the landscape and irrigation system. The landscape project is scheduled to be completed by the end of the year. As for the Plan, a complete draft copy will be scheduled for staff review by the end of the year. The Plan is scheduled for City Council consideration in early 2021.

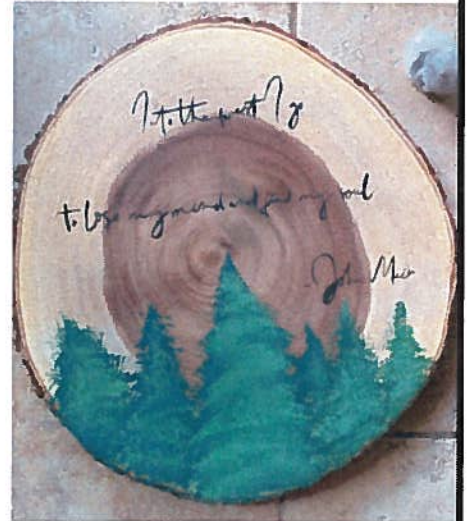

Dear Mayor Jones,

Thank you for your invitation to discuss key priorities in upcoming coronavirus relief legislation. Over the past three months, Congress has taken unprecedented action to address the coronavirus pandemic and resulting economic crisis, including providing \$3 trillion for coronavirus testing and health care, worker and small business relief, and state and local aid. But the continuing economic hardship we are facing requires that Congress continue to act.

Among my top priorities is to provide additional assistance to state and local governments that have suffered unprecedented budget shortfalls due to necessary stay-at-home orders, rising expenses to deal with the virus, and a sharp reduction in economic activity and associated tax revenue. I support Governor Newsom's call for \$1 trillion in additional assistance for state and local governments, and I have cosponsored several bills to provide additional funding for this purpose.

Congress should also consider a number of other priorities for future relief legislation, including significant funding for housing and homeless assistance programs, support for renters and landlords, and nutrition assistance; additional funding for coronavirus testing and contact tracing and support for local public health agencies; additional relief for businesses that is tied to rehiring and retaining employees; and funding for critical infrastructure projects, such as transit, broadband, and clean energy. I have shared these priorities with congressional leadership in the attached letter.

We share many priorities, including that the health of Californians is of paramount concern, we must balance and achieve the goals of public health and reopening the economy, and that we can't accomplish one without the other. Thank you for all of your hard work in navigating our communities through this unprecedented crisis.

Dear Leader McConnell:

As you negotiate the next coronavirus response bill, I ask that you include the following priorities that are critical to California:

1. Flexible assistance for state and local governments
2. Housing and nutrition assistance
3. Health-related funding
4. Augment the CARES Act's small business lending program
5. Critical infrastructure project funding

California was the first state to issue a stay-at-home order, meaning that its businesses have been closed and suffered as much harm as any other state's. As of May 4, California has had over 55,000 cases of coronavirus and 2,250 deaths.

The current public health and economic crises we face are unprecedented in our lifetimes. Congress must do everything it can to minimize the damage they are causing and prepare our society to recover as quickly as possible. The enclosed attachment provides detail on the requests I outlined above.

Attachment: Provisions Critical to California

1. **Flexible assistance for state and local governments**

Request: Substantial additional funding; flexibility to allow funding to be used to replace lost revenue (retroactive to *CARES Act* allocations); reduced population thresholds; multi-year expenditure authority; extending payroll tax credits to public agencies commensurate with their new paid sick and family leave requirements

State and local governments have suffered massive, unexpected losses to tax revenues and a spike in expenses due to the coronavirus and stay-at-home orders that have been necessary as a result. The Center on Budget and Policy Priorities estimates that state governments alone could face more than \$500 billion in budget shortfalls due to the virus and related stay-at-home orders. Cash reserves that many California jurisdictions have responsibly accumulated over the years will be depleted quickly and these governments will be forced to lay off teachers, firefighters, police officers, and other public workers or find additional revenue sources at the worst time, during a recession. In addition, the *Families First Coronavirus Response Act* compounded these budget shortfalls by requiring both businesses and state and local governments to provide paid sick and family leave, but only reimbursed businesses for that cost.

Providing substantial aid to these governments will promote public health, particularly since California's counties operate our public health departments, as well as economic recovery. The Economic Policy Institute found that a major reason for the slow economic recovery following the Great Recession was the relative cuts to public sector employment—largely by state and local governments forced to balance their budgets without federal assistance—compared to previous recoveries. We will be making a mistake if we allow much-needed public employees to be sacrificed again during this recession.

2. **Housing and nutrition assistance**

Request: Significant funding for homeless assistance programs, rental assistance, and housing vouchers; financial support for homeowners and landlords; a 15 percent increase to the maximum Supplemental Nutrition Assistance Program (SNAP) benefit.

Letter from Sen. Feinstein to Leader McConnell
May 7, 2020

The United States is facing a housing crisis that continues to worsen as a result of the ongoing pandemic. The federal government must support state and local governments that are doing all they can to get those at risk of becoming homeless—or those already homeless—into safe and affordable housing as quickly as possible to prevent further spread of the coronavirus.

A recent report estimates that individuals experiencing homelessness who contract coronavirus are twice as likely to be hospitalized, up to four times as likely to need critical care, and two to three times as likely to die as the general population. In California alone, state officials estimate that 60,000 homeless individuals could end up infected by the coronavirus, with up to 12,000 of them requiring hospitalization.

Furthermore, given the unprecedented disruption to the economy, with more than 30 million Americans having filed unemployment benefit claims, the need for an expanded and strengthened SNAP program is necessary to address food insecurity among recipients struggling to make ends meet during this crisis.

Food banks are now reporting that an additional 17.1 million people could experience food insecurity, a 46 percent increase from before the coronavirus outbreak. Unfortunately, the average SNAP benefit per person is about \$1.40 per meal per day—which is barely enough to buy one full meal, especially for those who live in states like California where the cost of living is high. During previous economic crises, Congress has helped prevent large increases in poverty by increasing the maximum SNAP benefit by 13.6 percent.

3. Health-related funding

Request: Additional funding for testing and contact tracing; delay implementation of the proposed Medicaid Fiscal Accountability Regulation; extension of California’s 1115 Medicaid waiver; pause of IMD exclusion; increase the federal Medicaid match to 12%

State and local public health agencies need federal assistance to ensure a robust testing system and contact tracing workforce can quickly identify and isolate COVID-19 cases in their areas. These agencies have estimated that at least \$7.6 billion needs to be appropriated in order to fund the necessary level of disease investigation specialists and contact tracing workers.

I have also heard from countless health providers regarding the need to delay the proposed Medicaid Fiscal Accountability Regulation by the Centers for Medicare and Medicaid Services, which would destabilize California's Medicaid program and negatively affect more than 1 million California patients who could lose access to care if it goes into effect. I also ask that all existing Section 1115 Medicaid demonstration waivers be extended for at least one year to provide continued flexibility for states to respond to the COVID-19 emergency.

Finally, we know of the terrible mental health toll this pandemic is having on the public and the damage it is doing to those already suffering from mental health conditions. For this reason, I ask that Medicaid's Institutions for Mental Diseases exclusion be paused during the COVID-19 pandemic to allow hospitals to better manage the surge in both inpatient and emergency departments to care for COVID-19 patients.

In addition to hospitals, health centers are on the frontlines of this pandemic and uniquely positioned to address the disparities it's creating for people living in poverty, those lacking housing, and communities of color. Every \$1 of federal funds for health centers generate \$5.73 nationally and saves the health care system \$24 billion annually. I urge that any health provider funding included be made available to Federally Qualified Health Centers, including Community Health Centers and Rural Health Clinics.

4. Augment the CARES Act's small business lending program

Request: Ensure that small businesses that most need aid—including women- and minority-owned businesses and the smallest businesses—have an equal opportunity to access relief funds; tailor the Paycheck Protection Program and other small business aid to address differences in business models; broaden eligibility for nonprofits not primarily engaged in political advocacy; improve application and funding processes

The Paycheck Protection Program created in the *CARES Act* has proven popular and helped many small businesses to stay afloat during the crisis, while also providing a compelling incentive for businesses to retain employees on payroll.

However, the program has been beset by problems. We have seen large disparities in per capita loan funding across states, with \$654 per capita in funding from the initial \$350 billion in lending provided to Nevada, compared to \$2,032 per capita to North Dakota. California received \$846 in PPP loans per capita in the first round of funding, which ranks 42nd among states, despite California's businesses having been closed longer than any other state. (This disparity has been partially mitigated during the second round of PPP funding that began on April 27.)

In addition, facing an overwhelming demand for loans, many banks have prioritized customers with existing lending relationships rather than providing equitable access to all small businesses, as Congress intended. This has led to relatively few funds being directed toward minority-owned businesses and businesses with few traditional banking connections. Further, the Small Business Administration has struggled to address structural problems with its online application process and getting funds quickly to approved small businesses.

The Paycheck Protection Program has provided hundreds of thousands of small businesses with needed funding, but Congress must address these substantial problems as well. I also ask that you consider making all nonprofit organizations—except for those engaged primarily in political activity—eligible for the Program. And it is important that arts and cultural businesses and workers have an equal opportunity to access relief more broadly as we move forward. Finally, I ask you to consider making the Program more flexible to handle certain types of businesses such as restaurants, tourism, and other sectors that may not be able to reopen or operate at pre-shutdown levels for many more months, or that tend to employ more low-wage workers that are not well-suited to meet its requirements for loan forgiveness.

5. Critical infrastructure project funding

Request: Extension of tax credits for clean energy; increase in fossil fuel excise taxes and royalties on public lands; flexibility for commencement of construction requirements for renewable energy projects; better broadband equity; improved natural disaster mitigation and resilience.

Letter from Sen. Feinstein to Leader McConnell
May 7, 2020

The impacts upon travel, telework, and distance learning have been changed for the indefinite future. While the CARES Act provided dedicated funding for airlines, airports, and transit, we must ensure these systems, as well as our roads and bridges, railways and ports, water and telecommunications systems, are resilient as schools, businesses and public spaces begin to reopen.

Existing infrastructure must be in a state of good repair with long-term sustainable funding which means setting a path towards zero carbon pollution from transportation while prioritizing safety. Tax credits for renewable power generation, energy efficiency, and building and transportation electrification must be extended with more flexibility due to impacts on construction. And, historic oil price lows provide an opportunity to reduce our dependence on fossil fuels while industries, such as steel and manufacturing, must be supported with strong domestic requirements and incentives to sequester carbon.

Further, increased work-from-home and school-from-home require more robust and better broadband service, both in terms of access and cost, for unserved and underserved rural, suburban and urban communities. And, finally, with wildfire season approaching in California and across the West, a more modernized 9-1-1 public safety network, a decentralized electric grid, and federal programs that promote mitigation and resilience from all natural disasters and keep students and parents online to learn and work from home is imperative for a cleaner energy future.

Orange County Housing Finance Trust

2019 – 2020 ANNUAL UPDATE REPORT



The Orange County Housing Finance Trust (Trust) was formed in 2019 as a collaborative, regional entity between the County of Orange and various cities throughout the county. The Trust currently has 23 cities and the County of Orange as members of the Trust. The Trust represents over 80% of the population in Orange County with the mission to strengthen communities by financing the development of affordable and supportive housing.

Not even twelve months has passed since the first Board meeting and the Trust has achieved some significant accomplishments.

At the May 6, 2020 Trust Board Meeting, seven affordable housing developments received a combined total of over \$10 million for the development of affordable and supportive housing. The Trust funding will be deferred loans that will help create 467 new housing units.

The Trust obtained funding from a variety of sources including the County of Orange Mental Health Services Act (MHSA) funds, a County of Orange General Funds grant to the Trust, a State of California General Funds grant to the Trust, and a contingent source of funds from the State of California from their newly funded Local Housing Trust Fund (LHTF) program exclusively for local and regional housing trusts. The Trust will apply for the LHTF grant funding through a competitive grant process issued by the State of California to local and regional housing trusts.

The Trust Notice of Funding Availability (NOFA) produced applications that were reviewed based upon scoring in several categories that included selection criteria guidelines to ensure funding would be initially available equally among the three County Service Planning Areas (North, South, Central) and prioritization of funding for those projects that were ready to start construction within eighteen months.

Other accomplishments in the last twelve months include:

2019 – 2020 ACCOMPLISHMENTS

- Receipt of \$1,000,000 grant award from the State of CA (HCD) to the Trust.
- Conducted OCHFT first election of officers.
- Facilitated Bylaw Ad Hoc Committee and finalized Trust Bylaws.
- Prepared first Notice of Funding Availability (NOFA) and awarded \$10 million to seven (7) projects to help finance 467 affordable and supportive housing units.
- Created Trust website at www.ochft.org
- Created an online mapping tool to track the number and location of affordable and permanent supportive housing units since June 2018.
- Adopted the first Trust budget.
- Initiated Trust 5-year strategic plan process to use as a blueprint for the next 5 years.
- Created Funding Strategy Ad Hoc Committee and initiated efforts to work with Trust lobbyists and State legislators to obtain additional State funding for Orange County.

Some of the items being worked on for the fiscal year 2020 – 2021 include:

- Prepare Trust loan documents related to \$10 million in funding.
- Initiate and manage the 2nd Trust NOFA in 1st quarter 2021 (\$10 million) for the development of affordable and supportive housing.
- Research and apply for State funding eligible to the Trust.
- Continue to work on legislative and/or lobbying efforts to secure additional funding from the State for administrative and development funding.
- Manage the Ad Hoc Formation Committee to explore Trust tax-exempt donations to fund more affordable and supportive housing.
- Finalize the Trust 5 Year Business/Strategic Plan. This document will identify the strategies that will best enable the Trust to advance its mission. It will help guide the organizations long-range goals. It will provide an organizational and financial plan for the next 5 years.

Why is SCE requesting this rate increase? SCE delivers your electricity. Every four years, SCE must file what is known as a General Rate Case (GRC) application with the CPUC. GRCs set rates that customers pay to fund SCE's day-to-day operations, including maintenance for its equipment and electricity grid upgrades.

How could this affect my monthly bill? If SCE's rate request is approved by the CPUC, the average residential monthly bill would increase by approximately \$14 in 2021, \$4 in 2022, and \$6 in 2023.

How does the rest of the process work? This application has been assigned to a Judge, who will consider all proposals and evidence presented during the formal hearing process. The Judge will issue a proposed decision which may adopt SCE's application, modify it or deny it. Any CPUC Commissioner may sponsor an alternate decision. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners.

The Public Advocates Office (Cal Advocates) is currently reviewing this application. Cal Advocates is the independent consumer advocate within the CPUC with a statutory mandate to represent customers of investor-owned utilities to obtain the lowest possible rate for service consistent with safe and reliable service and the state's environmental policy goals. Cal Advocates has a multi-disciplinary staff with expertise in economics, finance, accounting and engineering. County of Orange Provides Clarification for Local Businesses After State Issues New Guidance for Reopening Additional Industries

Santa Ana, Calif. (June 5, 2020) – The California Department of Public Health (CDPH) released new guidance for the reopening of additional sectors of economies in jurisdictions like Orange County that have already submitted an attestation and received approval to move deeper into Stage 2 of the State's Resilience Roadmap.

These newly issued guidance provides corresponding sectors with information on public health modifications they should implement prior to opening, and state that they may only reopen upon approval by the County Health Officer. Upon review of local data related to COVID-19 spread and Orange County's readiness, the County Health Officer will make a final decision about the timing for re-opening a sector, which may happen no sooner than June 12, 2020.

These sectors include:

- Campgrounds, RV Parks, and Outdoor Recreation
- Cardrooms, Satellite Wagering Facilities and Racetracks
- Family Entertainment Centers
- Fitness Facilities
- Hotels
- Museums, Galleries, Zoos, and Aquariums
- Restaurants, Bars, and Wineries

The County Health Officer will review Orange County's epidemiological data including cases per 100,000 population, rate of test positivity, and local preparedness to support a health care surge, vulnerable populations and contact tracing, and give sector-by-sector approval for these industries to re-open as appropriate. The County looks forward to sharing approvals with the community via press releases.

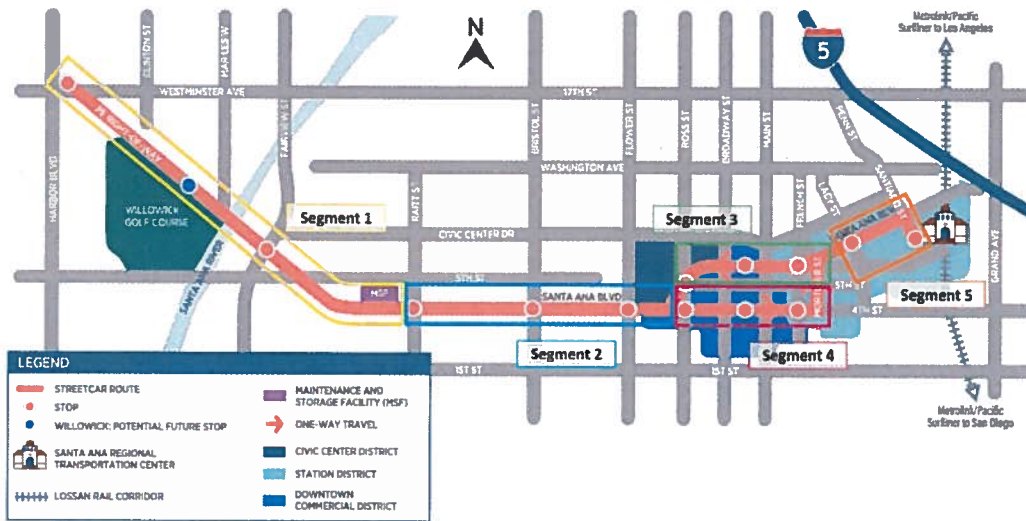

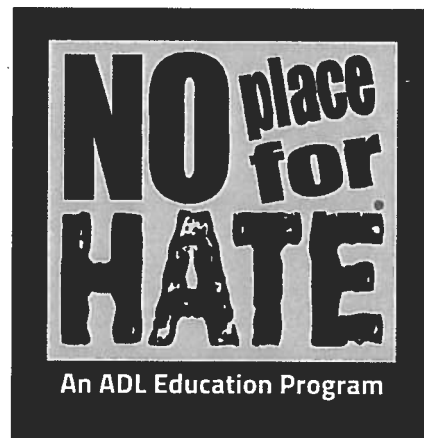

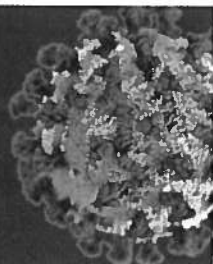

Virtual graduations are being held district-wide in an effort to celebrate and honor our graduating Class of 2020 in a manner that follows the Stay-at-Home order and ensures the health and safety of our students, staff, and families. Currently, California and Orange County have orders that restrict public gatherings, even when social distancing is in place. Thus, no event can be held at a school facility that gathers students and parents/families from across multiple homes, even given social distancing. Additionally, each high school has had or is planning cap and gown or diploma pick-ups, and other school-based or parent-led celebratory activities with the caveat that students and families must remain in their cars in keeping with state and county guidelines. While the district will allow schools to engage in these drive-through style of celebrations, our campuses remain closed to the public, and public gatherings may not occur on campus. The safety of our students, staff and families is our highest priority. Once restrictions on public gatherings are lifted and large events such as graduation, hosting thousands of people in a stadium, are allowed, we will survey senior students and parents on possible postponement dates and determine next steps. In the interim, we want to honor and celebrate our graduates on their designated graduation day.

High school collects \$10,000 for needy

The staff at Los Ami-

gos High School in Garden Grove Unified School District collected \$10,000 to help its students and families who are facing financial hardship because of the coronavirus crisis.

The idea came from teachers Kerry Bernhardt and Babak Mobasseri, who were discussing how distance learning and the current work-from-home environment have allowed them to save money on gas, car insurance and similar expenses. The teachers wondered how they could use the money they saved to

help Los Amigos students and their families.

Under the leadership of Los Amigos librarian Christina Fenner and math department chair Christi Montes, the staff donated \$7,300, including funds from their own government stimulus checks. Schools-First Credit Union chipped in \$1,000 and students in the school's Girls' League donated \$2,500.

Teachers and counselors generated a list of students whose families are struggling and sent the families \$100 Walmart gift cards, a list of local resources and a note of encouragement.

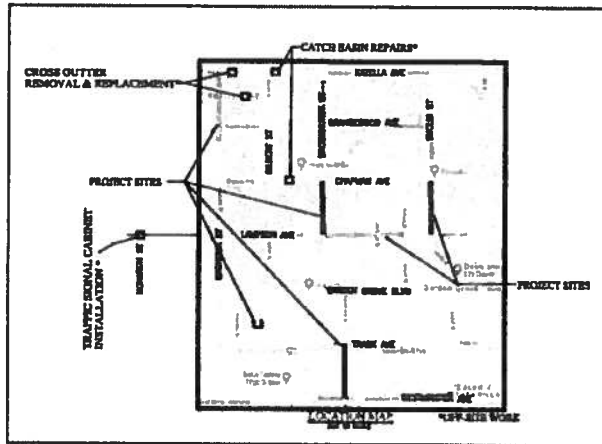

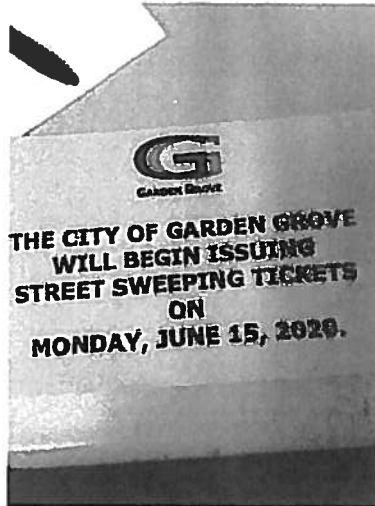

REVIEW OF THE CODE OF ETHICS: The Commission reviewed and acknowledged the Code of Ethics governing the Neighborhood Improvement and Conservation Commission.

BROWN ACT: City Attorney, Omar Sandoval, presented an outline of the Brown Act to the Commission.

MATTERS FROM STAFF: 2019 HOUSING ELEMENT ANNUAL PROGRESS REPORT (APR): The staff report dated March 2, 2020 was introduced. Staff provided the Commission the opportunity for engagement, discussion, and input on the City's progress in implementing the 2013-2021 Housing Element.

Staff stated that the Housing Element was one (1) of the seven (7) mandatory elements of the General Plan. The Housing Element specified ways in which the housing needs of existing and future residents could be achieved. Consistent with the State Housing Element law, Housing Element progress must be analyzed annually and the Element itself updated every eight (8) years.

To that end, the City was required to produce an Annual Progress Report (APR) on the status of the Housing Element in order to monitor progress in addressing housing needs and goals. The APR includes information on the City's progress in addressing its Regional Housing Need Allocation (RHNA), which includes the number of new units constructed; the number of existing units rehabilitated; the number of units permitted by the City; and the status of programs listed in the Housing Element.

As determined by the Southern California Association of Government (SCAG), Garden Grove's fair share allocation of housing units during the 5th RHNA Cycle was 747 units. The report outlined the progress as of planning year six (6) of the 8-year cycle.

Staff recommended that the NICC:

- Review and issue comments regarding the Housing Element Annual Progress Report, and
- Recommend its transmittal to the City Council.

It was moved by Commissioner Hanssen and seconded by Commissioner Swaim, to accept staff's recommendation to transmit the Housing Element Update to the City Council. The motion carried by a 6-0 vote as follows:

Absent: (1) Pham

STAFF INTRODUCTIONS: Division Manager, Greg Blodgett, and Sr. Project Manager, Monica Covarrubias, both from the City's Office of Economic Development/Neighborhood Improvement Divisions, introduced themselves to the Commission and were available for contact if Commissioners had questions.

MATTERS FROM COMMISSIONERS: Commissioner Hanssen acknowledged the good work done in her district by Council Member John O'Neill, the police department, and code enforcement, for ensuring 'pop-up tent' vendors who sell, for example, phones or insurance, were legally permitted.

Commissioner Swaim mentioned that he sat in for Commissioner Flanders on the ESG Collaborative volunteer position, working with Tim Throne, and noted that the event was a great learning experience and encouraged other Commissioners to take part. He then asked if the NICC packet could be sent digitally as well as the paper version and asked to be sent the link for the online agenda. Lastly, he recognized Chair Blackmun being chosen as Woman of the Year by the Chamber of Commerce.

Commissioner Newbold then brought attention to the City's adopt-a-tree program, which for \$55, a tree would be planted in a residential parkway, and noted he would canvas his neighborhood residents to encourage them to adopt and once again have tree-lined streets. He also encouraged the City to provide an online payment feature to accept the fees. He then mentioned that an isolated area, behind the water pump station, in the far-east side of West Grove Park, needed better lighting as people use the spot to camp overnight pushing the dark area to be a future hazard. Lastly, he pointed out that West Grove residential tract street signs were faded and needed to be replaced as a whole.

Staff responded that for street signs needing replacement, a form could be filled out online with a response from Public Works in one to two days, however, Public Works would be contacted as general replacement was needed.

Chair Blackmun asked what process was used to report and clean-up private properties with junk all around. Staff replied that Code Enforcement would be the point of contact for problem properties and, if necessary, follow-up would include notices and fines for violations.

Commissioner Flanders noted that all types of complaints could be input on the City's website as well as the app.

Commissioner Flanders asked if mosquito issues could be reported to the City. Staff responded that the lead contact would be County Vector Control, however, Code Enforcement could also be contacted.

ADJOURNMENT: The meeting was adjourned at 7:21 p.m.

FCC Action Limits Local Authority Over Modifications to Existing Wireless Facilities

June 10, 2020

At a Federal Communications Commission (FCC) meeting June 9, the commission voted to adopt a Ruling and Notice of Proposed Rulemaking to “clarify” and change FCC rules pertaining to modifications of existing wireless facilities.

The changes limit local control in various ways, including by increasing the height of additional antenna permitted to be added to existing towers by right, and by undoing protections used by local governments to preserve concealment elements or enforce prior conditions of approval.

Cities who have questions about how this Ruling and Notice of Proposed Rulemaking may impact their city should consult with their city attorney.

The changes in the Ruling became effective immediately upon release, while the changes in the Notice of Proposed Rulemaking are subject to further stakeholder comments over the next 30 days.

The FCC’s action was prompted by petitions filed in late 2019 by wireless industry advocates. The League is a part of a coalition of local governments and local government associations – the Western Communities’ Coalition – that has been actively engaged in opposing these petitions and advocating on behalf of local governments, including, most recently, by filing comments amidst the COVID-19 pandemic. The League will continue to advocate against these efforts by the industry to limit local control.
